

Cocomelon Calico Bag Colouring In Competition Terms & Conditions

2. *Only residents of Australia aged 0yrs of age or older (Participant) are eligible for the Competition. Participants must obtain the prior permission of a parent or guardian over the age of 18 years to enter the Competition, evidenced by the parent or guardian signing the entry form.*
3. *The following person(s) are ineligible to enter the Competition:*
 - a) *employees of:*
 - I. *the Promoter; and*
